INSTALLATION OR USE OF THE KIT, WHICHEVER COMES FIRST, CONSTITUTES THE ACCEPTANCE OF THE TERMS SET FORTH BELOW. IF YOU CHOOSE NOT TO ACCEPT THESE PROVISIONS, DO NOT INSTALL OR USE DOME. This agreement authorizes the Customer to use the DOME BA KIT on a non-assignable, nontransferable (without any right to sublicense), non-exclusive, limited, and revocable license only for the authentication of approved enrolled and managed devices and, if electing to enroll and manage devices, with a VERIDIFY approved cloud-based software-as-a-service.

The Customer may not rent, lease, license, transfer, assign, sell, or otherwise provide access to the DOME BA Kit, in whole or in part, on a temporary or permanent basis to any third-party without VERIDIFY's prior written consent. The DOME BA KIT is not intended for use in nuclear, aviation, mass transit, medical, lifesaving or life-sustaining applications, or other inherently dangerous applications or other equipment in which the failure of DOME could lead to personal injury, death, physical or environmental damage. Customers using the DOME BA KIT in such applications do so at their own risk and agree to fully indemnify VERIDIFY for any damages resulting from such improper use or sale. VERIDIFY disclaims liability for any damages caused by such use. Customers are responsible for their products and applications using the DOME BA KIT, which may deviate from published specifications as a result of design defects, errors, or operation of products outside of published parameters or design specifications. All parties submit to the non-exclusive jurisdiction and venue of the state and federal courts in the State of Connecticut, U.S.A. If any of the terms are held by a court of competent jurisdiction to be invalid, void, or unenforceable, then that term held to be invalid, void, or unenforceable shall be enforced to the maximum extent permissible so as to effect the intent of the Agreement, and the remainder of the terms shall remain in full force and effect, and in no way shall be affected, impaired, or invalidated. Customer agrees that any preliminary or final order or judgment issued against Customer shall be enforceable in the domestic court of Customer and that Customer promptly shall provide any consents or stipulations necessary to facilitate enforcement of such orders or judgments in the domestic courts of the Customer against which enforcement is sought.
